# Report Dates Subject to Withholding of State or Federal Aids FY 2023-24

The purpose of this document is to notify districts, in accordance with § TCS 7.09(1), Wis. Admin. Code, of reports to be filed with the System Office and the respective due dates for filing each report during the next fiscal year. The following schedules list only those reports that are continuing in nature. Ad hoc or additional reports may be required during the year, but are not subject to withholding of state or federal aids unless they are subject to s. 38.28(2)(d) and (e), Wis. Stats.

<u>Schedule A1 – State Aids Reports</u> details the reports subject to withholding of state aids.

<u>Schedule A2 – State Aids Other</u> identifies ongoing submission requirements regarding district board policies and budget modifications.

Schedule B – Federal Aids details the reports subject to withholding of federal aids.

<u>Schedule C – Master Calendar</u> is a calendar of reports to be submitted to the System Office, including those subject to withholding of state or federal aid (or both) and those which are not subject to withholding of aids. For each report the System Office administrative and programmatic contacts are listed. These individuals are available to provide clarification on the form and content of required reports.
