Purpose

The Wisconsin Technical College System (WTCS) Board awards funds to support the adoption, development and expansion of Open Educational Resources (OER). Open Educational Resources (OER) are learning, teaching and research materials in any format and medium that reside in the public domain or are under copyright that have been released under an open license (e.g., Creative Commons), that permit no-cost access, re-use, re-purpose, adaptation and redistribution by others. For more information, please see our "WTCS What is OER?" video.

Funding in this grant category can be used toward three OER goals:

- Adopt existing OER in courses that currently do not use/require OER. See the WTCS OER
 Repository and appendix for list of instructional areas that are well-suited for OER
 adoption work.
- 2. Adapt or create new OER for courses that do not have readily adoptable OER options.
- 3. Consortium OER Projects that convert key courses to no-cost OER content in prioritized instructional areas (*invitation-only*).

Funds Available and Additional Limitations

• Up to \$3,000,000 will be available for these purposes for FY23-24.

- On an invitation-only basis, an award will be granted to one Wisconsin technical college to act as
 a fiscal agent and manage grant activities that support the development of one or more
 Consortium OER Projects. Each Consortium OER Project will be awarded \$200,000 and this
 funding must be spent on the OER deliverables for that project. In the case that a lead college is
 managing multiple Consortium OER Projects, the lead college will submit a separate application
 for each Consortium OER Project.
- For the first two goals that provide funding/stipends for institutional OER work of (1) adopting
 or (2) adapting/creating OER, the funding will be allocated to each college based on the
 proportionate share of unique courses (college-level and adult education/English language
 learning) for instructional areas with available OER and instructional areas without available
 OER.

Measurable Objectives

The objectives in this grant are to expand the access and adoption of Open Educational Resources across the Wisconsin Technical College System, which includes:

- Increase college affordability by removing course material barriers for WI Technical College students through the adoption of OER. Increase the number of WI Technical College students who enroll in OER courses that do not have course material or courseware costs.
- Adopt existing OER for WI Technical College courses with readily available open content (e.g., general education courses).
- Adapt, develop and create new OER for WI Technical College courses, especially within prioritized career and technical education areas.
- Share newly developed OER across the WI Technical College System to maximize the adoption of these resources across all WI Technical Colleges with similar courses.

Allowable Activities

- Up to 5% can be allocated toward administrative costs.
- This funding can only be used to support the adoption, adaptation and creation of open educational resources.
- Goal 1: Adopt existing OER.
 - Stipends for faculty time and effort to adopt existing OER into their courses. See <u>stipend</u> recommendations.
 - Salary/stipends for faculty support staff (e.g., OER librarian)
- Goal 2. Adapt/Create new OER.
 - Stipends for faculty time and effort to adapt/create OER for their courses. See <u>stipend</u> recommendations.
 - Salary/stipends for faculty support staff (e.g., OER librarian)
- Goal 3. Consortium OER Projects (invitation-only)
 - Salary, stipends and contracts for OER creation project members to develop grant deliverables, including stipends/contracts for review of OER content, project management, etc. Project members should include employees of the grantee lead college and employees of other WI Technical Colleges.

- Compensating students for work to support OER projects (e.g., review OER content, provide feedback, help develop open content via open pedagogy and co-creation, captioning videos, etc.).
- Staff professional development for successful OER development and creation.
- Travel to Systemwide events to share OER grant deliverables and content with System colleagues.

Reporting requirements

- For adopted OER, share OER adoption information with College OER Champion for addition to the WTCS OER Repository
- For adapted/created OER: Share direct link to the developed OER deliverables with the System
 Office and College OER Champion for addition to the <u>WTCS OER Repository</u>. OER deliverables
 must be published/released with a Creative Commons license. Upload adapted/created OER to
 <u>WISELearn Resources</u>.
- Completion of the <u>WTCS OER Creation Project Checklist</u> for each Consortium OER Project (invitation-only) included within the grant report.
- Report the number of students enrolling in course sections that adopt OER due to the work of this grant using the Client Reporting Program Fee Code '71' for OER. See reporting guidance.

Stipend Recommendations

To ensure that faculty across the System are being compensated equitably in OER work, please see the recommended stipend amounts for Goals 1 and 2.

Stipend	Stipend	What is required
Category	Amount	
Adopt	\$1,500	Identify and use an existing open textbook or other OER for your course to remove textbook/courseware costs for students. Share OER adoption with college's OER Champion for inclusion in the WTCS OER Repository.
Adapt/Create	\$2,500	Identify and customize existing OER and/or create new OER to align with your course. This includes creating an updated or localized edition of an existing open textbook, creating a new open textbook or course shell, and creating supporting materials (e.g., assessments, slide decks, videos, or interactive media). The adaptation/creation of OER must remove textbook/courseware costs for students. All newly created or adapted OER must be made available with the appropriate license (e.g., Creative Commons) and shared with college's OER Champion for inclusion in the WTCS OER Repository, shared with the System Office in the final grant report and uploaded to WISELearn Resources (Wisconsin's OER Commons Site).
