GRANT PROGRAMS ELIGIBLE FOR COURSE FEE EXEMPTION

Courses funded by grants are not automatically exempt from charging In State Tuition (Program and Material fees) or Out of State Tuition unless specifically exempted by the System Office or the grant is exempted from course fees by the federal, state, or private granting agency.

In State Tuition refers to Program Fees as defined in [Wis. Stats. 38.24\(1m\)](#). Out of State Tuition is defined in [Wis. Stats. 38.24\(3\)](#).

For courses not specifically exempted from fees by a federal, state or private granting agency, WTCS rules allow districts to apply for an exemption to charging In State and Out of State Tuition for grant funded courses provided:

- 1) the grant funding is equal to or exceeds the amount of In State Tuition, and Out of State Tuition that would have been collected if the course(s) were not exempt, and
- 2) the goals of the grant are best served by an exemption, as determined by the WTCS Provost.

If a grant has been approved for Statewide Exemption, then all colleges participating in the grant and awarded funding will be required to exempt tuition.

Table H provides a list of grants determined to be eligible for this exemption along with a list of those specifically determined not to be eligible.

Note: All grants in this table will be reviewed annually to verify that grants appearing as exempt are still active.
